

## **Supplementary Agreement for On-line Registration for E-bill Service**

This Agreement is Supplementary to the Megaline (single/double/Triple Play) / FTTH (single/double/Triple Play) / LTE Single Play-voice(voice PAL / LTE broadband only /LTE double play CDMA(Pre & Post Paid) Agreements.

This Agreement shall be read together with the aforesaid telecommunication Service Agreement/s entered into between the parties for the existing connection and shall form a part and parcel of the said Agreement/s.

The following terms and conditions serve as guidelines in addition to the information published in the SLT web site. I agree to carefully read & understand the Terms & Conditions set forth herein and in the SLT website.

By clicking the “I Accept” [\* Pleases refer the Asterisk below] box below, I acknowledge that I have read, understood and accept the following;

**1. Consent to online self registration**

I, agree that I have read carefully, understood and agree to be bound by the terms and conditions of Online E-Bill Service of SLT (hereinafter referred to as ‘Service’) before registering myself for the said Service.

**2. Amendments and Modifications**

I acknowledge that the website ([www.slt.lk](http://www.slt.lk)) (herein after referred to as the ‘vide Website’) may be modified from time to time without notice to me, as such I agree to update myself and be bound by the Terms and Conditions published in the Website. I agree that my use or access of this Service and/or Website is conclusive proof of my agreement to be bound by the terms and conditions applicable for the Service and in the event I am not agreeable to the terms and conditions hereof I shall immediately stop using or disconnect the Service without prejudice to the liabilities incurred by me.

**3. Customer Obligations**

3.1 I shall maintain the availability of email access and active email account at all times material to this Agreement to receive the e-bill.

3.2 In the event of any change of my e-mail address, I shall immediately inform SLT (either to SLT regional office/ Teleshop/ SLT account manager for enterprise customer/s) to update SLT systems with the new e-mail address to which I wish to receive the e-bill.

3.3 In the event of my failure to maintain the said email account, I shall immediately inform SLT (either to SLT regional office/ Teleshop/ SLT account manager for enterprise customer/s) the request to receive the bills in print format.

- 3.4 It shall be construed that I am aware of the bill arrears and/or is in receipt of the e-bills in the event if I have not informed any inability to receive e-bills and/or any change of the e-mail address and/or requested to receive bills in hardcopy.
- 3.5 Nothing hereof shall in anyway discharge my liability with regard to settlement of any outstanding bill arrears.
- 3.6 The e-bill sent to the e-mail address given by me shall be constructive proof of receipt of the e-bill/invoice for SLT services by me for all purposes.
- 3.7 In the event I wish to change the format of receiving the bill (from e-bill to hardcopy), I shall inform SLT of the same in writing either to SLT regional office/ Teleshop/ SLT account manager for enterprise customer/s or by email addressed to 1212@slt.com.lk). The requested change will be effected from the next billing month.
- 3.8 I hereby undertakes not to plead prescription in any action by SLT.
- 3.9 I understand that in the event I register for SMS alerts for this Service, I may receive SLT promotional SMS, bill payment reminders or any other special messages related to SLT product and services.

#### **4. Termination**

- 4.1 In the event the telephone services provided to me are disconnected, this Service will be automatically suspended / terminated.
- 4.2 SLT may suspend/terminate the Service if it detects any misuse by me.
- 4.3 In the event I detect a misuse by a licensee under me, I shall forthwith change the password and if I so wish will, immediately notify SLT to terminate the Service.

#### **05. Fees and Payments**

- 5.1 This Service shall be offered to me free of charge.
- 5.2 I shall bear any cost incurred in using the service through the internet, which cost shall be calculated in preparing the monthly bill.

#### **06. Indemnity**

- 6.1 I shall indemnify SLT of any misuse or negligence of using the Service on my part.
- 6.2 I shall indemnify SLT of any transaction effected under my user ID.
- 6.3 I shall indemnify SLT and keep SLT indemnified against non-receipt of any e-bill due to internet outage or disruption

#### **07. Intellectual Property Rights**

I acknowledge that all the intellectual property in relation to this Service belongs to SLT and I shall not misuse, modify, reverse engineer, decompile or disassemble any software used by SLT in provisioning the Service.

#### **08. Confidentiality**

I hereby undertake to SLT, that I shall keep in the strictest confidence, except where disclosure is required by law, any confidential or proprietary information or intellectual property of any nature belonging to SLT which may come into my possession or to my knowledge during my association with SLT, except where the prior written consent of SLT is obtained.

**09. Content Ownership**

- 9.1 I agree that all content created and published on the Website and SMS alert facility belongs to SLT or SLT Group of companies or authorized to use it. I agree that non of such content or intellectual property rights shall be used by me without proper written authority of SLT.
- 9.2 I further agree that I shall not publish any content in the Website or in the Online Self-Registration Portal of SLT.

**10. Links to other websites**

- 10.1 I understand that SLT site may contain links to third party web sites which are not owned or controlled by SLT and therefore would not be responsible for the content, privacy policies or practices of such third party websites.
- 10.2 I agree that access to such sites are at my risk and SLT is not liable for any loss or damage caused to me by relying on the information in such linked sites.

**11. SLT Rights**

- 11.1 I agree that the provision of the Service will be at the discretion of SLT.
- 11.2 I agree that SLT has right to request further information and documentation whether on line or not prior to provisioning of the Services.
- 11.3 I understand that SLT has right to monitor and control my access rights
- 11.4 I agree that SLT may terminate this Service for its convenience.
